The Embassy of the People's Republic of China in Nepal presents its compliments to the Ministry of Finance, Government of Nepal and has the honor to inform the latter as follows:

The Government of China would like to invite with pleasure the Government of Nepal to nominate candidates to this year's MOFCOM scholarship programs, which will offer full scholarship for winning candidates to study master/PhD diplomas in China. MOFCOM scholarship programs are part of the Chinese government assistance to developing countries. The goal is to help developing countries to educate top-level, inter-disciplinary and application-oriented talents in broad areas, and help their social and economic development with knowledge know-how and intellectual support.

The general requirements of nominated candidates include, but not limited to: minimum three years' related work experience, government/public or related sector employment, English proficiency level at IELTS 6.0/TOEFL 80, under the age of forty-five and of required health conditions. Other specific requirements can be found in the respective documents of each scholarship program. Nominated candidates shall go through multiple rounds of competitive selections, and the best ones will be awarded scholarship and enrolled to their respective universities and subjects.

The nomination deadline is set separately on June 30 for some programs and May 31 for others. The number of nominated candidates shall not exceed two persons for a single program, and the total number shall not exceed eighty persons for all programs. Nominated candidates shall register themselves and submit documents online followed by interview

and document verification offline. Because of the limited number of seats and advanced deadlines in some programs, the nomination is expected to be made the earliest possible so that candidates could have more chances of winning over those of other countries.

In line with the MOU on Human Resource Development Cooperation between China International Development Cooperation Agency and the Ministry of Finance of the Government of Nepal, signed on June 21st, 2018, the Ministry of Finance of the Government of Nepal is kindly requested to disseminate the Scholarship programs to related ministries/organizations, coordinate their selection process and nominate to the Economic and Commercial Counselor's Office of the Chinese Embassy within the timeline.

The Embassy of the People's Republic of China in Nepal avails itself to this opportunity to renew to the Ministry of Finance, Government of Nepal assurances of its highest consideration.
